Privacy policy Hoogendijk Import Export BV

Hoogendijk Import Export BV will carefully store and secure your (personal) data. In this privacy statement we explain for you which personal data we process, collect, use and for what purpose. We hereby comply with the General Data Protection Regulation (AVG) which is effective from 25 May 2018.

Collecting and providing data

By using the website of Hoogendijk Import Export BV or if you register for our newsletter we receive information from you, this may be personal data. We only keep and use the information that you provide to us or which it is clear that these are provided to us to process.

We offer a newsletter in which we inform you about our products and services. You must first sign up for the newsletter. Your e-mail address may or may not automatically be added to the list of subscribers. A link has been included in the newsletter with which you can unsubscribe.
